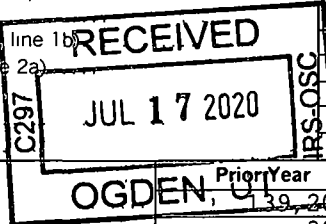

Land and Water Protection: To respond proactively to our climate crisis we partnered with the county planning department to reforest stream buffers in the Agricultural Reserve with locally grown native trees by launching the Re-Leaf the Reserve program. MCA engaged residents in the county's long range planning campaign, Thrive 2050, to ensure that as the county considers future development patterns, critical protections for farmland and our shared water supply continue.

4b (Code) (Expenses \$ 39,273. including grants of \$) (Revenue \$)

Education: We partnered with local high schools for the 6th year of our education program to bring farmers to classrooms and students to farms. We engaged the general public through our 12th annual Ride for the Reserve fall bike tour and helped launch PLENTY magazine, the only publication specifically dedicated to Montgomery County's Agricultural Reserve. The 2019 Royce Hanson award honored career Ag Educator Lori Mayhew and the generation of agriculture stewards she launched.

Farmer Support: Since 2011 MCA has matched 25 new or expanding farmers with long term leases on local land - now totalling over 500 acres of matches. Through information sessions with farmers and online information campaigns, we promoted newly legal crop hemp as a boon to soil health and profitability. Sessions with local farmers and landowners also promoted regenerative agriculture - land management practices that sequester carbon and reduce water use. We promoted local food products and CSA programs and continued to grow our producers listserve to help farmers share knowledge and equipment.
