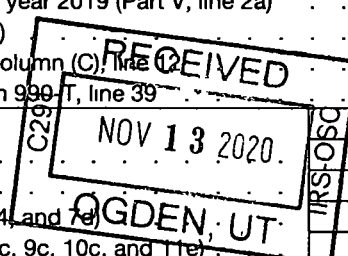

2019 conference had 91 educational seminars conducted by 41 speakers. In addition, numerous vendor workshops were put on
by some of our 120 vendors to familiarize potential, new, and continuing home educators with available materials and techniques.
The conference was attended by over 6200 people representing over 2000 families.

Generate a magazine mailed to the members of North Carolinians for Home Education to keep members abreast of resources
available to homeschools and homeschoolers. Publications consist of Spring and Fall issues with a special Graduation issue,
that includes graduating student bios. Format is journal-style of approximately 44 pages in length with about 3,000 copies
printed and distributed for each edition.

NCHE Athletic Commission organizes and administers regular season leagues and post-season tournaments in the traditional
high school sports. These teams compete against other homeschool, private school, and public school teams. Sports covered
include Baseball, Basketball, Cross Country, Fencing, Soccer (Boys and Girls), Swimming, and Volleyball.
All told, 145 teams serve 1650 student athletes.
