By elevating the physician voice in this critical health equity issue, KCMS Foundation supports increased access to healthcare in our community. Building a diverse medical workforce. The KCMS Foundation leads a Wyandotte County coalition working to develop an education-to-employment pipeline for multilingual, multicultural health professionals. Promoting wellness and prevention. A physician-led committee is working to address key health issues across the community through education and advocacy.
