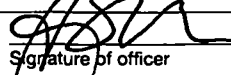

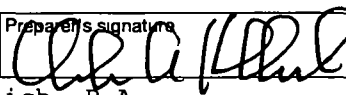

The Clinic has a strong 30 year history of serving the uninsured and medically underserved families of Broward County by providing free essential primary and specialty health care services in 16 different areas of specialty along with testing and treatment. During the 2018-2019 program year, the Clinic provided a total number of 12,576 patient encounters including 4,278 patient visits, 3,700 labs/vaccines, 824 diagnostic imaging/tests, 1,895 eligibility/intakes and 249 specialty referrals. In addition, the Clinic provided health outreach to 1,625 individuals through community outreach efforts including health fairs, wellness and special events. Basic health care services were provided by a continuum of 60 licensed and 302 non-licensed volunteers.
