The Center's achievements during the year included: 1. Operated two offices in two counties, providing an accessible family center and library with resources, information, and consultation with staff on a wide range of services and activities. Hours of operation: Monday - Thursday, 9am - 5pm.; 2. Provided 59 relevant trainings in group settings; 3. Offered families 41 social activities for parents, children, siblings and extended family; 4. Provided 42 outreach activities to agencies serving children with disabilities/special needs and the general community.
