We accomplish our mission providing recreational, educational, and sport programming, including vocational/pre-vocational opportunities, to youth at risk and persons with disabilities. Individuals are accepted without regard to race, religion, ethnicity, or socioeconomic background.

Teaching people with disabilities to ride and care for horses and preparing them to show at the Top Hands Horse Show and the Aldine ISD 2019 and 2020 Livestock Show. In 2019, we taught 240 lessons to 43 athletes utilizing 96 volunteers who gave 4002 total hours. Additionally preparing our new facility for habitation, our horses spent time in Cat Spring and The Woodlands, TX. Program was interrupted significantly from January until April. Since then program has operated in dry weather under spartan conditions at our current home of 20907 Birnamwood Blvd, Humble, TX 77338.

Providing adjudicated youth with the opportunity to serve their assigned community service hours - This included teaching them to use a garden rake and shovel to clean and repair the facility, pick up litter, assist with the daily care of the horses and preparation for construction. Upon completion of their hours each has a better understanding of how to stay out of trouble, repair their credibility and standing in the community. Success rate continues at 95% returning them to positive life pathways.

4c (Code:) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 0)

Utilizing volunteers to feed and care for our horses, instruct our people with disabilities, supervise adjudicated youth, maintain and construct our facility and complete all administrative and fundraising work - A total of 96 volunteers (including adjudicated youths) gave 4002 hours to operate Dream Catcher Stables program and prepare our site for construction. These hours do not include the administrative, fundraising, or site preparation work. Joining our 2020 Board of Directors is the gentleman who turned our "black gumbo soup" into "concrete clay" so that we can survive until the permitting process is completed and our buildings can be built. More importantly this gentleman, dealing with major diabetic foot problems and limited eyesight, turned his life around by regaining his lost self-esteem. Our volunteer Speech Pathology Assistant was admitted to the Baylor University graduate school speech pathologists program with a full scholarship. She looks forward to receiving her M.S. in May 2021 and continues to volunteer.
