Justice ReformA Positive Youth Justice System (PYJS) ReportIn January 2019, NICJR released A Positive Youth Justice System, a report and campaign that provides a roadmap to comprehensive reform The juvenile justice system can be successfully reformed if we Reduce, Improve, and Reinvest significantly reduce the size and number of youth in the system, thoroughly improve the conditions and services provided and improve the outcomes of the small number of youth who remain in the system, and use the hundreds of millions of dollars in savings from a massive reduction in the size of the system to reinvest in youth, their families, and the communities where they live NICJR received significant response after the release of the report, including several jurisdictions requesting technical assistance to implement a PYJS and several invitations for NICJR Executive Director and primary report author, David Muhammad, to speak David also published an op-ed summarizing the report for the Chronicle of Social Change and appeared on the Annie E Casey Foundations podcast to discuss PYJS with the Foundations new President Neighborhood Opportunity and Accountability Board (NOAB)In Oakland, NICJR is developing the Neighborhood Opportunity and Accountability Board (NOAB) model, an initiative that seeks to transform the youth justice system by empowering youth and community members to determine how youth who commit delinquent acts can be engaged in positive developmental strategies as opposed to relying on punitive, deficit-based practices The NOAB also seeks to reinvest the significant resources spent on a dysfunctional system into communities, families, and youth Initially, the NOAB will serve as a local program in Oakland that will divert youth from the juvenile justice system and, instead, utilize neighborhood councils to address delinquent behavior The NOAB Steering Committee, which includes representation from community leaders, youth development professionals, restorative justice professionals, the Oakland Police Department, Alameda County Juvenile Probation, the Alameda Countys District Attorneys Office, Restorative Justice for Oakland Youth, the Carl B Metoyer Center for Family Counseling, and Youth Uprising, met monthly in 2018 to develop the pilot program set to launch in August 2019 The NOAB has built tremendous support from community and system stakeholders and is in the process of raising additional funds for program implementation Los Angeles County Probation Over 2018-19, NICJR played a major role on the team of advisors to the Los Angeles County Board of Supervisors in the development of a comprehensive assessment of the countys Probation Department The year-long study culminated in the publishing of a detailed Governance Report in March 2018 on how to thoroughly reform the largest probation department in the country Following completion of the Governance Report, the Board of Supervisors created the Probation Reform Implementation Team (PRIT) to help implement the numerous recommendations in the report NICJR currently provides technical assistance to the PRIT and is the primary author on the pending Reform Prioritization Plan being developed by the PRIT The City and County of San Francisco Over 2018-19, NICJR began working with the City and County of San Francisco Department of Children, Youth, and their Families (DCYF) to deliver programmatic technical assistance and capacity building to justice agencies and community-based organizations The agreement with the City was amended after the Board of Supervisors announced its intention to close the sole juvenile detention center in the City The Mayor then announced the formation of a Blue-Ribbon Commission to develop recommendations for the reform of the juvenile justice system Along with James Bell and Shawn Ginwright, NICJR was asked to serve as a consultant and technical assistance provider to the Mayors Blue-Ribbon Commission Massachusetts In February 2019, NICJR provided a full day training on Positive Youth Development (PYD) to Massachusetts juvenile justice and child welfare agency staff as well as local community service providers Nearly 100 officials from these agencies participated in the training, held at Boston University, which focused on how PYD can be implemented in the juvenile justice system The training included the provision of specific implementation tools that participants designed to ensure the ultimate goals of reducing the number of youth in the system and improving the outcomes of the youth who remain Rutherford County, Tennessee Over 2018-19, NICJR provided a four-day training for all probation officers in a newly created Probation Department in Rutherford County The county had been sued for using a privately run probation department which was imposing excessive fines and fees and violating clients probation resulting in high incarceration rates Following the lawsuit, the county ended the private probation contract, created a government agency to provide probation services, and asked NICJR to train all probation officers in positive client development, implicit bias, and procedural justice

Gun Violence Reduction Oakland, CANICJR provides technical assistance to the City of Oakland's Gun Violence Reduction Strategy, also known as Ceasefire. The initiative has been credited, and verified through a rigorous external academic evaluation, with being the primary cause of a 50% reduction in injury shootings and homicides in the City of Oakland over the past six years. NICJR released a publication on Oakland's Gun Violence Reduction Strategy in February 2018. Portland, OR In partnership with the California Partnership for Safe Communities, NICJR provides technical assistance, consulting, and training to the City of Portland to develop an effective Gun Violence Reduction Strategy. NICJR will help the City design a new violence reduction strategy, develop protocols for outreach workers and provide training in these protocols, and help develop a service coordination process to focus outreach and support efforts on the highest risk individuals in the City. Stockton, CANICJR has provided on-going technical assistance, consulting, and training to the Stockton Office of Violence Prevention (OVP). NICJR has helped design and implement the OVP's gun violence reduction strategy. NICJR wrote the operational protocols manual for the OVP and trained all staff in the new protocols. Additionally, NICJR has helped to facilitate a partnership between Advance Peace and the City of Stockton to implement the Peacemaker Fellowship. Over 2018, Stockton achieved a 40% reduction in shootings. Indianapolis, IN Since 2018, NICJR has provided technical assistance to the city of Indianapolis to strengthen its Gun Violence Intervention Program. In this role, NICJR has worked with the Mayor, city officials, and community and clergy leaders to implement an approach similar to the Oakland Ceasefire Strategy that targets individuals at the highest risk for gun violence. Cost of Violence Studies NICJR has conducted and published a series of studies on the cumulative costs of homicide and injury shootings for several cities across the country. These studies are primarily used by community advocates to try to build political will to move away from traditional and ineffective violence reduction strategies and to pilot or adopt key components of NICJR's violence reduction model. In partnership with Rev. Michael McBride and the Live Free network, NICJR has published Cost of Violence studies for Orlando, FL, Miami Gardens, FL, Indianapolis, IN, Detroit, MI, Birmingham, AL, Mobile, AL, Dallas, TX, and St. Louis, MO. NICJR is currently conducting a Cost of Violence study in Portland, OR and received funding from the Hope and Heal fund to conduct studies in Stockton and San Bernardino, CA.

Young Professionals of Color FellowshipIn partnership with DeVone Boggan of Advance Peace and Rev Michael McBride of Live Free, NICJR launched the Young Professionals of Color (YPOC) Fellowship in July 2018. The YPOC Fellowship is a leadership development opportunity specifically designed for emerging leaders advancing the well being of communities of color through various avenues of social justice. Through the fellowship, NICJR and its partners have worked to develop extraordinary leadership and cultivate expertise among young professionals of color in the fields of criminal justice reform, urban gun violence reduction, community organizing, and social justice generally. Fellows participate in a series of learning engagements that provide them the opportunity to network with and learn from a variety of leaders in the social justice. The inaugural cohort of the YPOC Fellowship features seven young professionals who were selected from a pool of candidates across the state and hold various positions in the fields of public health, violence reduction, criminal justice reform, education, youth development, community organizing, and public safety. Fellowship convenings focus on building leadership capacity and feature professional development and training opportunities covering a cross section of topics including fund development, organizational management, fiscal management, public speaking, networking, strategic planning, policy development, branding, communications, and more. Fellowship convenings also feature guest lecturers with extensive expertise and a demonstrated track record of innovative leadership in their respective fields including Angela Glover-Blackwell, Chet Hewitt, Arnold Perkins, Lateefah Simon, Michael McBride, DeVone Boggan, David Muhammad, Shawn Ginwright, Arnold Chandler, Jacqueline Martinez Garcel and several more to come. The convenings provide an opportunity for fellows to build personal relationships with these esteemed leaders in intimate settings, which has already resulted in long-term mentorship opportunities for the fellows.
