THE LEAGUE ORGANIZES AND EXECUTES FIVE RACES EACH YEAR IN WHICH THESE TEAMS COMPETE, IN ADDITION TO PROVIDING TEAM, COACH, AND ATHLETE TRAINING AND SUPPORT. OVER \$7,800 IN SCHOLARSHIPS AND \$3,175 IN LOANER BIKES WERE AWARDED TO DESERVING ATHLETES AND COACHES.
