28 The Pruno Fund is a charitable organization established to help exonerated men and women succeed in transitioning from prison to life on the outside by providing certain grants. The Fund offers Emergency grants for the critical needs of the Exoneree such as, housing and utility bills, doctors visits and essential transportation needs. The Fund also provides a one-time Education grant for tuition and books for an academic or job skills training program. Our emergency grant program has, by far, been the most requested and is the largest Pruno Fund program service representing the majority of our expenses. Since we began awarding grants, to date, our Emergency Grant program has awarded a total \$20,660.00 to 32 grant recipients. Our second largest program is our Education Grant Program and to date since the incorporation of the organization we have offered one Education Grant in the amount of \$1,051.00. The majority of our remaining expenses are for marketing and technology costs for current programs and those in development.
