UNDER CORPORATE LAW, OFFICERS AND DIRECTORS ARE TRADITIONALLY SEEN AS DISTINCT POSITIONS, WITH OFFICERS SERVING AS OFFICERS OF THE CORPORATION, NOT THE BOARD. SO, THIS SECTION WAS TO ADDRESS SOLELY OUR LEADERSHIP POSITIONS ON THE BOARD (CHAIRPERSON AND VICE-CHAIR) AND MOVE THE DESCRIPTIONS OF SECRETARY AND TREASURER TO ARTICLE IV, WHICH ADDRESSES OFFICERS OF THE CORPORATION. ALSO, THE REFERENCE TO THE CHAIRPERSON AS BEING THE "PRESIDENT" OF THE ORGANIZATION WAS REMOVED BECAUSE THIS IS NOT ACCURATE AS THE PRESIDENT IS THE OFFICER WHO IS IN CHARGE OF THE DAY-TO-DAY AFFAIRS OF THE ORGANIZATION, WHICH MORE PROPERLY RESIDES IN THE EXECUTIVE DIRECTOR. -ARTICLE III (BOARD COMMITTEES).
