THE MIDWEST MINIATURES MUSEUM PRESERVES AND EXHIBITS A COLLECTION OF FINE ART MINIATURES INCLUDING SCALE REPLICAS OF HISTORIC BUILDINGS, DOLL HOUSES, ROOM BOXES, AND COLLECTIONS OF INDIVIDUAL PIECES OF DECORATIVE ART, MOST NOTABLY MINIATURE SILVER. ITS PURPOSE IS TO EXHIBIT MINIATURES IN AN EDUCATIONAL CONTEXT FOR THE PUBLIC, AND TO FOSTER THEIR APPRECIATION AS WORKS OF ART USED IN MYRIAD WAYS. THIS YEAR, THE MUSEUM WAS OPEN 208 DAYS BETWEEN APRIL AND NOVEMBER. IT WELCOMED 5,850 VISITORS TO ITS COLLECTION, AND OFFERED FREE, GUIDED TOURS OF ITS GALLERIES TO EVERY GUEST. IN AUGUST, THE MUSEUM PURCHASED A NEW BUILDING TO HOST IMPROVED EXHIBITS OF ITS COLLECTION AND TO REACH BROADER COMMUNITIES IN GRAND HAVEN, MI.
