Workforce Development - Our Workforce Development program promotes the advancement of low wage workers, the underemployed, and the under-represented. In 2019 the Insight Center continued our efforts to advance the well-being of Mississippians disconnected from employment and education, focusing on Black and low-income persons in certain counties. Following up our examination of regional labor markets, the workforce system, barriers to work, and structural factors such as occupational crowding, we identified opportunities for careers in middle-wage jobs and sought to lift up community driven solutions that promote opportunities and remove barriers. In addition to our work in Mississippi, we continued our efforts in the San Francisco Bay Area to address employment equity for formerly incarcerated persons. We wrote a report on the Bay Area's Fair Chance Workforce, with a focus on the experience of individuals and communities of color and systemic barriers to quality jobs. We hosted a podcast that discussed the roots of the criminal justice system and the power of local organizing in fighting anti-Blackness and discriminatory policies. We presented findings and recommendations at local and regional workshops and conferences. We also connected these efforts with our larger advocacy toward eliminating harmful court fines and fees, as well as other policies and practices that perpetuate racial and gender inequities in the local workforce development system.

4b (Code:) (Expenses \$ 158,948 including grants of \$) (Revenue \$ 45,650)

Asset Building - Our Asset Building Program promotes policies and practices that enable people and communities to acquire, accumulate, and preserve financial and educational assets. In 2019 the Insight Center continued our efforts that focus on debt mechanisms targeting and disproportionately affecting communities of color. We worked to expand the number of local jurisdictions that eliminate or sharply reduce all local administrative fees, and successfully partnered with the San Francisco Office of Financial Justice and a diverse coalition to eliminate all locally controlled fees associated with the city's criminal justice system. We continued efforts to analyze the causes of racial wealth inequality, releasing The Color of Wealth in Miami in partnership with the Kirwan Institute for the Study of Race and Ethnicity and the Samuel DuBois Cook Center on Social Equity. We made presentations on the racial wealth gap, the status of women and wealth, and the need for funders to support policies and programs aimed at advancing millennial women wealth. We released Clipped Wings, a report that described why millennial women are encountering financial difficulties. We facilitated the first of two racial equity trainings to over 60 government officials in the City of Philadelphia, and supported the city's government officials, policy advocates, and other municipal stakeholders in the implementation of the city's racial equity plan. Finally, we analyzed and discussed in various forums universal basic income strategies to address poverty and racial equity.

4c (Code:) (Expenses \$ 38,752 including grants of \$) (Revenue \$ 8,000)

Economic Security - Our Building Economic Security for All Program promotes the use of more accurate measures of family and elder need, and uses these measures to design more effective programs and shape public policy. In 2019 the Insight Center conducted in-person trainings and presentations to over 500 stakeholders on the newly updated California Family Needs Calculator (formerly Self-Sufficiency Standard) for workforce development boards, law and policy advocates, philanthropic investors, and government officials across California. We facilitated two trainings for First 5 Alameda to enhance its use of the Calculator in its work. We began to identify continued funding for the Calculator to generate a new set of data in 2020, and criticized a proposed federal poverty measure rule change that would lower the poverty line instead of raising it, based on the Calculator's findings. We also used the Calculator's data in trainings with local and regional Bay Area stakeholders on the roots of Bay Area racial inequities, including disparities across health, housing, childcare, and criminal justice. We continued to assist the United Way of the Bay Area's campaign to cut poverty in half in the San Francisco Bay Area by 2020, including presentations at its Rise Together Economic Summit. We co-released The Payback Problem: How Taking Parent's Child Support Payments to Pay Back the Cost of Public Assistance Harms California's Low Income Children and Families, and promoted efforts to change state and local policies that unfairly take child support payments from families.
