This neighborhood is actually referred to as a "Food Desert" because there is no place to buy healthy food here. There is only one liquor store here to buy food. Residents have to travel a few miles to get healthy, non-processed food because there are no markets around us. I am grateful for all that my parents have done for me. It is because of them that I am motivated in starting a career in the medical field. They have always supported me. There is no excuse to not succeed. Thanks to them, I am the 1st and only person in my family that has graduated from college. I am eager to continue advancing in my educational life, eventually becoming a Radiologist. I love helping people, and I really want to help those that have always been there for me as well. I want to give my parents the best, just like they gave me the best to succeed.
