(FOUNDATION) WAS ORGANIZED IN DECEMBER 1986 AS A NONPROFIT ORGANIZATION TO CARRY FUNDRAISING ACTIVITIES ON BEHALF OF SAN DIEGO HOSPICE AND THE INSTITUTE FOR PALLIATIVE MEDICINE (SDHIPM). ON FEBRUARY 4, 2013, SDHIPM FILED A PETITION FOR RELIEF UNDER CHAPTER 11 OF THE UNITED STATES BANKRUPTCY CODE. ON OR ABOUT SEPTEMBER 23, 2013, AN ORDER WAS ENTERED CONFIRMING A PLAN OF LIQUIDATION. THE FOUNDATION CONTINUES TO EXIST AND NOW SUPPORTS LOCAL NONPROFIT HOSPICE SERVICES THROUGHOUT SAN DIEGO COUNTY. IN ADDITION, THE SAN DIEGO HOSPICE FOUNDATION ASSISTS IN DEVELOPING, ESTABLISHING, AND CONTINUING ACTIVITIES AND PROGRAMS WHICH WILL ENABLE AND ASSIST RESEARCH AND SCIENTIFIC GOALS AND OBJECTIVES TO FURTHER THE STATED PURPOSES.











