MEMBERSHIPWe launched a Digital Organizing Department that conducted digital organizing training for our staff and worker leaders in minimum wage worker mobilization campaigns. We also trained all our staff members on using social media marketing, digital call to action, and digital fundraising to better track membership growth and retention. We used our program activities to raise funding and awareness about issues faced by low-wage restaurant workers. Despite the pandemic, in 2020, our Digital Department ROC chapter staff have helped file many unfair labors practices, EEOC, or wage board cases, as well as providing know your rights training to thousands of workers. We grew our online members by more than 20,000 in a single year. In addition, we increased the number of RAISE restaurants to more than 900850 by the end of the year. The program now includes informational materials, webinars, and rapid response support from our Digital and Communication Departments and has grown exponentially.

EMPLOYER EDUCATION ENGAGEMENT COLORS AND CHOW In 2020, we stopped running business operations in all Colors restaurants to focus on workers and employer engagements. In addition, we launched our CHOW e-Learning platform to continue training low-wage workers during the pandemic. We added new classes such as management and entrepreneurship for low-wage women, immigrants, and people of color. Our CHOW school of training graduated more than 250 workers. In New York alone, we trained 160, and more than 60 of the workers who graduated gained employment by mid-2021.

RESEARCH AND POLICY POLICY - After the pandemic shut down restaurants across the country, ROC began aggressively organizing to support policies initiatives beneficial to restaurant workers, including paid sick leave, hazard pay, PPE, and the right to return to their employer. ROC organized restaurant workers to demand those basic protections for workers at all major chains. Darden quickly provided paid sick leave to all its employees at the start of the pandemic. Over 10,000 workers at Dine Brands IHOP Applebees, over 3,000 workers at Dennys, and over 1,000 workers at Chilis signed petitions demanding paid sick leave and emergency assistance to all of their employees. Restaurant workers and allies sent over 500,000 emails to Applebees corporate and franchise headquarters, requesting paid leave and emergency assistance, leading Applebees to provide paid sick leave for all corporate employees. Chilis provided emergency financial assistance to impacted employees.
