COP25: In 2019, SustainUs sent its first ever indigeneous delegation to COP25 in Madrid, Spain. The delegation amplified the voices of marginalized communities, and centered indigeneous culture, impact, and spirituality into their work. Indigeneous communities are almost always excluded from negotiations and the UN does not recognize groups' national sovereignty with voting rights or negotiating powers. This delegation was a direct response to the historical and current impacts of colonialism, exclusion, and erasure of indigenous peoples.

World Bank Delegation: In 2019, a delegation of 10 young people (ages 18-28) from Washington D.C., Maryland, and Virginia attended the World Bank Annual Meetings from October 13th - 19th in Washington, D.C. to advocate for climate justice and stand in solidarity with frontline communities in World Bank client countries.

UNSG Climate Summit 2019: SustainUS sent a delegation of 10 New York area youth to the UNSG (UN Secretary General) Climate Summit. The Summit was held at the UN Headquarters in New York City during the second week of the UN General Assembly (UNGA) and the delegates mission was to create a robust strategy both in and outside of the Summit walls. The delegation served as the planning group for a local training curriculum, and helped develop demands that connect local campaigns to international policymaking on climate action.
