DAY SERVICES - THE DAY SERVICES CONSIST OF EMPLOYMENT SERVICES AND THERAPEUTIC DAY SERVICES. OUR EMPLOYMENT SERVICES ENCOURAGE INDIVIDUALS TO EXPLORE CAREER INTERESTS AND DEVELOP JOB SKILLS. ASSISTED BY JOB COACHES, MANY PARTICIPANTS ARE PLACED INDIVIDUALLY OR AS A MEMBER OF A CREW IN JOBS WITHIN A VARIETY OF COMMUNITY BUSINESSES. JOB TRAINING AND EMPLOYMENT ARE AT THE FOREFRONT BUT INDIVIDUALS ALSO VOLUNTEER IN THE COMMUNITY, EXERCISE AT THE YMCA, PARTICIPATE IN OUR HORTICULTURAL PROGRAM,TAKE COMPUTER AND COOKING CLASSES AND TAKE PART IN OTHER MEANINGFUL ACTIVITIES.
