JOURNALISM - WHEN THE CORONAVIRIUS STRUCK, CW IMMEDIATELY PIVOTED TO FOCUS ON JOURNALISM THAT WOULD SHED LIGHT ON THE IMPACT OF THE VIRUS ON OUR COMMUNITY, AND POLICIES THAT COULD MITIGATE ITS STAGGERING BLOW. ACCOMPLISHMENTS INCLUDED BREAKING THE NEWS ABOUT THE COVER UP OF THE NUMBER OF DEATHS IN MA NURSING HOMES, PARTICULARLY THE VETERANS NURSING HOME, WHICH LED TO GOVERNMENT TRANSPARENCY AND ACCURATE REPORTING. CW ALSO BROKE THE NEWS THE THE STATE'S UNEMPLOYMENT INSURANCE WEBSITE WAS ONLY IN ENGLISH AND DIFFICULT TO NAVIGATE, WHICH LED TO THE TRANSLATION OF THE SITE INTO MULTIPLE LANGUAGES AND IMPROVEMENTS IN NAVIGATION. OUR SMALL TEAM OF FOUR JOURNALISTS WORKED DAY AND NIGHT TO EDUCATE THE PUBLIC ABOUT THE IMPACT OF COVID FROM INTERESTING AND INFORMATIVE ANGLES AND AS A RESULT WE SAW A 127% INCREASE IN WEB TRAFFIC IN 2020.

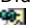
