IN 2020, WE CONTINUED TO CENTER OUR WORK AROUND OUR STRATEGIC PRINCIPLES:1. CREATE A BIG SOCIAL CHANGE THROUGH MEANINGFUL, INCREMENTAL STEPS.2. BUILD A COALITION THAT IS BIGGER THAN OURSELVES.3. DEVELOP A MOVEMENT THAT IS STRONGER EACH YEAR.IN REALIZING THESE PRIORITIES, WE IMPACTED THE LIVES OF 623 MILLION ANIMALS RAISED FOR FOOD.
