Forgotten VoicesEnvironmental injustices are complex issues that not only sit at the intersection of class and race, but also need to be examined and approached at every level of government: federal, state, county and city. In addition to the environmental and health impacts of polluting industries, environmental justice communities in California also deal with a lack of infrastructure and access to resources. Historically, City and County governments have used local land use policies to racially segregate communities through redlining which restricted where people of color could own property. Often these areas were within or next to areas zoned for industrial use, designated for highway construction, or for waste disposal. Climate JusticeClimate change is an issue that needs our immediate attention. Its impacts are already being felt across the globe and in California, yet they do not affect everyone equally. CRPE approaches the issues of climate change and energy through the lens of climate justice. We address these issues by focusing on the racial, social and economic inequities of climate change and by prioritizing local solutions to this global problem.CRPE uses its unique blend of community organizing, litigation and policy advocacy to address the dual threats that low-income communities and communities of color face: disproportionately suffering from the effects of climate change, and the effects of policy decisions to address global warming. Californias industrial-style, factory farm dairy industry began a rapid expansion in the 1990s and now is one of the leading air, climate, and groundwater polluters in the San Joaquin Valley. After Arvin residents asked for help in 1998, CRPE launched our dairy work by stopping several, massive dairy proposals. Working with communities, CRPE has made a huge impact on this problem by successfully forcing transparency and accountability, ending an agricultural exemption for air quality controls, and working to impose the most stringent air pollution controls in the United States.Toxic Free Communities (continued from Form 990 Page 2)treatment of toxic waste. Currently, CRPE along with our allies are changing the framework of that fight by building a statewide collaborative effort to reform the Department of Toxic Substances Control.In California, DTSC is the state agency tasked with overseeing hazardous waste management and clean-up. DTSC has systemically let down our most exposed communities in each of their main duties: permitting waste sites, enforcing waste laws and cleaning up contaminated waste sites.We also include pesticide work in this area as it relates to toxics. Pesticides have an especially harmful effect on farmworkers, but also on nearby communities due to pesticide drift. Exposure to pesticides has been linked to serious health issues ranging from cancer to developmental issues in children. Pesticides also form compounds that contribute to poor air quality, and the San Joaquin Valley has some of the worst air in America. The Valley regions of Fresno-Madera, Visalia-Porterville-Hanford, Bakersfield and Modesto-Merced repeatedly rank in the top 5 for the worst ozone pollution and fine particulate pollution, according to the American Lung Association. Pesticides rank among the top contributors to that pollution.CRPEs approach to tackling pesticides is twofold. First, we organize and educate residents about the realities of pesticides. Farmworker and farmworker communities historically have been systemically denied access to accurate information about the dangers of pesticides, some reporting that they are simply called medicine for the crops. By conducting community meetings and holding regional trainings, we are taking the first step towards healthier communities. Second, we help to push for stricter pesticide regulations by educating legislators and connecting key decision makers with impacted residents. Past victories have included the adoption of a quarter mile buffer zone between pesticide application and schools in Tulare County and the adoption of the first ever air pollution restrictions for pesticides. Our current campaign is focused on ending telone banking, calling for a minimum one mile buffer zone between schools and pesticide applications, and improving the pesticide notification project in Kern County.
