THE PURPOSE OF FUNDING IS TO KEEP INDIVIDUALS AND FAMILIES SAFELY HOUSED DURING THE COVID-19 PANDEMIC, TARGETING RENTERS NEGATIVELY IMPACTED BY COVID-19. CIRI IS COLLABORATING WITH LOCAL CONNECTICUT ORGANIZATIONS TO ENSURE THAT THE ASSISTANCE WAS PROVIDED TO THE APPROPRIATE RECIPIENTS. DURING 2020, THE RENTAL ASSISTANCE IMPACTED OVER 2400 INDIVIDUALS.

IN COLLABORATION WITH SOCIAL SERVICE AGENCIES, LEGAL SERVICES, AND LAW ENFORCEMENT, THE PROGRAM HELPS SURVIVORS GAIN ACCESS TO PUBLIC BENEFITS, THERAPY, SAFE HOUSING AND THE MEDICAL CARE THEY NEED TO REBUILD THEIR LIVES. PROJECT RESCUE PROVIDES STATEWIDE TRAINING TO SERVICE PROVIDERS AND LAW ENFORCEMENT ON VICTIM IDENTIFICATION AND OUTREACH TO INCREASE PUBLIC AWARENESS. THE PROGRAM ALSO COLLABORATED WITH STATE AND NATIONAL NETWORKS TO SECURE SAFETY AND RESETTLING OF UNACCOMPANIED MINORS IN SHELTER AND AS THEY MOVE FROM SHELTER TO THEIR SPONSORS/FAMILY MEMBERS.

REFUGEES HAVE FLED WAR AND PERSECUTION IN THEIR NATIVE COUNTRIES AND IN MANY CASES HAVE SPENT YEARS, EVEN DECADES, IN REFUGEE CAMPS. THE INSTITUTE STAFF FOCUSES ON MEETING THE IMMEDIATE BASIC NEEDS OF NEW REFUGEES, AND ASSISTS WITH EMPLOYMENT, HOUSING, SCHOOL READINESS AND SUCCESS IN THE US EDUCATION SYSTEM, ACCESSING HEALTH SERVICES, AND OTHER SERVICES SO THEY MAY THRIVE IN THEIR NEW COMMUNITIES. ECONOMIC EMPOWERMENT: FOCUSED ON BUILDING THE ECONOMIC INDEPENDENCE AND SECURITY OF CIRI'S CLIENTS, THE PROGRAM HOUSES CIRI'S WORKFORCE READINESS AND JOB PLACEMENT FUNCTIONS AS WELL AS FINANCIAL LITERACY EDUCATION.
