Neighborhood Funders Group (NFG) is a network of national and local grantmakers throughout the U.S. Our mission is to organize philanthropy to support grassroots power building so that communities of color and low-income communities thrive. We bring together funders to learn, connect, and mobilize resources with an intersectional and place-based focus.

In 2020, in partnership with Amalgamated Charitable Foundation, NFG’s Amplify Fund continued organizing funders to support over 50 organizations and movements in California, Missouri, Nevada, North Carolina, Pennsylvania, Puerto Rico, South Carolina, and Tennessee. In 2020 Amplify facilitated rapid response COVID19 grants in each of these eight places.

In March, NFG pivoted its programming to be fully virtual. Our Funders for a Just Economy Program’s annual Policy Briefing in March served as a critical moment for funders to learn in real time from grassroots leaders what was happening to low-income essential workers and their families as the COVID19 pandemic hit the U.S., and how labor organizing was severely impacted.

NFG’s Integrated Rural Strategies Group shined light on rural communities around the country that are neglected by philanthropy, building new funder relationships and bringing attention to rural issues and Black, Indigenous, and people of color organizing in Alabama, Arizona, Georgia, Michigan, Minnesota, Montana, New York, North Carolina, Oregon and Pennsylvania. NFG’s Multi-Racial Rural Equity Summit (July 2020) brought together 120 attendees and resulted in moving over \$50,000 to five rural, grassroots nonprofits whose work was featured throughout the Summit.

Shortly before the COVID-19 shutdown, in February 2020 NFG’s Democratizing Development Program organized a sold-out, two-day in-person event in Oakland, CA - Health, Housing, Race, Equity and Power - that drew over 120 grantmakers. This was an important moment bridging the health and housing funding silos and centering funder discussions with the intersectional voices of grassroots organizers. Throughout 2020, NFG continued to convene funders virtually to learn directly from movement leaders on issues like gentrification and displacement, racial capitalism, multiracial rural organizing, and the changing landscape of workers’ rights. NFG organized over 40 virtual events - webinars, convenings, meetings, and connection spaces - to accelerate racial, economic, gender, and climate justice. Instead of an in-person multi-day national convening, due to the pandemic we pivoted our 40 Years Strong Convening to a series of virtual plenaries, workshops, and conversations from June through December. We also encouraged storytelling and connection through social media. The virtual conference and series were well-attended and prompted NFG to invest in more video production and upgraded IT security for our virtual events.NFG completed the second cohort cycle of its Philanthropy Forward leadership program for foundation CEOs. Fellows have shared that Philanthropy Forward has, as one put it, "centered me to be a leader, take risks, and not to follow" - giving them the courage to use their power and platforms to move more resources to Black, Indigenous, people of color and low-income communities. Two Fellows’ Philanthropy Forward journeys resulted in them moving millions of new dollars to Black communities and efforts to end structural racism. The Philanthropy Forward alumni network now includes 33 current and former foundation CEOs.Our member network grew from 120 grantmaking institutions at the end of 2019 to 137 by the end of 2020. Over 1,500 individuals were eager to come together virtually to problem solve, find connection, and strategize on philanthropy’s response to the year’s most pressing challenges.
