 Medical Care Program - Our commitment to helping children who would otherwise go without healthcare remained strong in 2020, changing lives in China, India, Cambodia and Uganda. We provided 778 medical procedures, including 125 cleft operations and 40 life-saving heart surgeries.

 Healing Homes Program- - LWB's Healing Home program serves children who are orphaned or abandoned. Most are malnourished, sick, or in need of urgent medical attention when found. This year, 86 vulnerable children stayed in our homes, and each one received the essential, life-affirming message that they are precious and worthy of love.

 Nutrition and Special Projects - - In 2020, our hot lunch program in Cambodia, located in two villages with high rates of chronic malnutrition, served 97,000 meals to LWB students. School gardens on both campuses helped provide a variety of healthy vegetables as well. LWB also supplied formula to babies in our healing homes and failure-to-thrive infants living in poverty. Emergency Food Relief: In 2020, COVID caused regions already struggling with poverty and malnutrition to reach a crisis point. LWB mobilized deliveries of life-sustaining staples such as rice, beans, and cornmeal to suffering communities. From April to December, we provided 485,283 pounds of emergency food supplies to children and their families, preventing over 36,400 people from going hungry. Family Strengthening: LWB is committed to building resilience in vulnerable families in the regions where we work. This year, we helped 27 children from our foster care and healing home programs have safe and healthy reunifications with their biological families. 8 income-generating projects were funded for single mothers, and 13 homes were built to provide secure housing for children living in unsafe conditions. 43 children received surgery through our China Unity program for desperate families unable to afford medical care.
