The Rockland County YMCA (Young Men's Christian Association) is a volunteer driven association that welcomes all people to programs that enhance their health and well being, strengthen their personal and family relationship, and enrich their spirits, minds, and bodies.

YOUTH DEVELOPMENT - The Early Childhood Programs provide affordable child care for over 101 children at Ys Beginnings Pre-School in Suffern. The School Age Care Department operated before and after-school child care in 13 sites during the first three months of the year. The program served 628 children in 4 school districts including Clarkstown, Suffern, South Orangetown and Nyack. The Fun Club, held on school breaks, served 33 children. It also offered a summer program for 36 youth at its main building in Nyack. During September through December virtual Assistance program that served 58 children was created and offered in the main building. North Rockland Program department operated before and after-school childcare programs at 5 schools during the 1st 3 months of the year of 213 children in the K-7th grade in the North Rockland Central School District. The "School's Out" program at Camp Bullowa served 64 children. A summer camp was operated in Pomona which served 101 campers from K-6th grade. During April through July an Emergency Childcare program was created. It served 4 children and from September through December an eight hour School Age program that served 115 children was offered in three schools in the North Rockland School District. The YMCA Emergency Child Care Centers operated at the Upper Nyack Elementary School and the West Haverstraw Elementary School between April and July 2020 to provide care for 23 children of first responders including nurses, physicians, police, firefighters and other essential workers. Activities included arts & crafts, table games, dance, supervised outdoor activities and homework assistance. This was a collaborative effort for the YMCA which provided the staff to plan and deliver the program, the Rockland BOCES which provided nurses and the Nyack School District and North Rockland School District which provided their space and meals to make these programs possible during the Pandemic. The Youth Department operated a summer teen program for 19 teens and separate Girls and Boys Mentoring Programs for 9 teens. The Youth and Government Program had 40 teens participate in a legislative and judicial program to develop leadership skills, public speaking and promote good citizenship in cooperation with local high schools. The Dance Department provided creative movement and dance classes for 63 youth to develop coordination and self-confidence. There are 261 children who learned to swim at the YMCA progressive swim program. Fitness programs for 224 youth and teens included soccer, basketball, tennis, fencing and karate, which develop skills and promote team work.

HEALTHY LIVING - The Aquatics Department provides a variety of programs including water exercise classes for older adults and those with disabilities, lifeguard training and swimming lessons. There are 8 adults who participated in swimming lessons and 31 teens and young adults in lifeguard certification courses. The Fitness Department provides instruction on using strength and cardiovascular equipment and offers health enhancement classes for adults and seniors to promote physical fitness and well being. Programs for adults also include many group exercise classes. The Enhanced Fitness Classes serve 26 seniors at the Nyack Senior Center and the Nyack YMCA facility.

SOCIAL RESPONSIBILITY- The YMCA operated the Childrens Center at the Family Court in New City, which served 122 children and 87 families between Januray and March 13th, 2020 when the Family Court was closed. The North Rockland Community Partnership Program, sponsored by a grant from the United Way, had a positive impact on 359 people. There were 18 adults and 18 youth who took part in strengthening families, 121 adults who took part in parenting sessions and 50 children in the after school tutoring and recreation program at the Haverstraw Center. There were 21 teens who took part in life skills classes and after-school physical education and sports activities at the NRHS extension. The YMCA provided childcare for 55 children. 76 parents took part in ESL classes by the Literacy Zone. There were 26 children who enjoyed who enjoyed the Family Recreation Swim Nights held at North Rockland High School. The YMCA Membership Department is located at the Nyack facility, which provides member services in the gymnasium, swimming pool, aerobics studio, fitness center and game room. The YMCA offers many activities that strengthen families, such as Family Swim Nights and Healthy Kids Day at its main facility. Overall, the YMCA served 4,371 members and 839 program participant members. Of all those, 50% of YMCA members are youth and teens. In 2020, 618 youth and 261 adults of low income families received \$111,816 of financial assistance and program subsidies for membership and to take part in YMCA programs, thanks to generous contributions and public support. Financial assistance is available for those who cannot afford to pay the full cost of membership or programs.
