DUE TO COVID-19, MANY OF THE IN-PERSON EVENTS WERE CANCELLED AND WE PIVOTED TO PARTICIPATION IN ONLINE FESTIVALS AND FOCUSED ON THE FILM'S THEATRICAL RELEASE AND STREAMING AVAILABILITY. WE ALSO CONTINUED TO FISCALLY SPONSOR FILMS AND PROJECTS THAT, LIKE OUR OWN, ARE IN LINE WITH AUBIN PICTURES' MISSION OF PROMOTING CULTURAL AWARENESS AND ACHIEVING SOCIAL CHANGE. ADDITIONAL PROJECTS THAT WE FOCUSED ON DURING THE FISCAL YEAR INCLUDED OUR INTERNSHIP PROGRAM AND JUST MEDIA PROJECT.
