Mujeres Unidas y ActivasIn 2020, we distributed over \$400,000 in cash relief and \$25,000 in gift cards to current and former MUA participants who had lost income due to the pandemic. We channeled an additional \$250,000 in cash relief to our community of participants provided by two partner organizations, the National Domestic Workers Alliance and the Family Independence Initiative. MUA offered peer counseling and services navigation by phone in Spanish five days per week, with hundreds of calls received per month. We helped members access food banks, social services, and unemployment. Our bilingual licensed clinician offered therapy via phone for the most challenging situations, as referred by our peer counselors. Through a partnership with Rubys Place domestic violence shelter, we also provided intensive peer counseling to Spanish language survivors in crisis situations. MUA recruited over 80 new MUA members in 2020.Throughout the year, we offered support groups, group life coaching, and Zumba fitness classes for our members over Zoom multiple days per week, with very enthusiastic participation. Our support groups typically had up to 80 participants participating via Zoom, whereas prior to COVID our typical support groups had 20-30 participants.Beginning in April 2020 we offered widely broadcast Facebook Live sessions in Spanish twice per week, with viewers all over the U.S. and Latin America. Our Tuesday Facebook Live sessions were conducted in collaboration with facilitating practitioners from NAKA Dance Theater, who provide guidance in trauma-informed healing, ancestral traditions, dance, meditation, nutrition, and health. The Thursday Facebook Live sessions focused on civic engagement and racial justice. We utilized these sessions to conduct voter education as well as to respond to the movements for justice for Black and Asian communities and to unite ourselves with these struggles.From July to December we offered 6 modules of vocational ESL (English as a Second Language) classes online three days per week, with a total of 47 women participating. The ESL classes offered an entry point for new women into MUA.In October we hired one of our Mam speaking member leaders to coordinate support programs for the Mam community, with an initial cohort of 19 participants. This year we launched two major impact evaluation studies. One study, funded by Robert Wood Johnson Foundation, is a retrospective study of our base-building and leadership development methodologies, and the other study, funded by Blue Shield of California Foundation, is an impact evaluation of whether our leadership model breaks the cycle of family violence. We expect to have preliminary results of these studies by fall 2021.Additionally, in partnership with the East Oakland Collective, NAKA Dance theater and loyal volunteers, we delivered healthy food, cleaning supplies, diapers and wipes to dozens of out of work MUA members in Oakland and south Alameda County from April to December 2020.

California Domestic Worker CoalitionIn 2020, MUA continued to anchor and fiscally sponsor the California Domestic Worker Coalition (CDWC). CDWC is the leading voice for the more than 300,000 housecleaners, nannies, and home attendants in California. Domestic workers are majority immigrant and women of color and 2020 more than ever showed the importance and value of their labor as essential workers in California. CDWCs work in 2020 focused on the impacts of the COVID-19 pandemic which devastated immigrant and working class communities of color throughout the state. Domestic worker communities experienced disproportionate loss of life and economic loss. CDWC responded with both economic relief to be distributed by its affiliated community based organizations as well as critical digital spaces for workers to share their experiences, stories, and needs. With the pandemic following ever-worsening wildfire seasons which have also led to hazardous working conditions for domestic workers, CDWC began advocacy for health and safety protections for domestic workers, who are the only workforce that remain excluded from the Californias Occupational Safety and Health Act. In June of 2020, CDWC also launched the California Domestic Worker Education and Outreach Program. At its core, this program empowers domestic and RCFE workers from diverse communities (Latino, Filipino, and Chinese) to lead the industries outreach, education, and rights enforcement strategies; the program also recognizes the importance of integrating employer outreach, organizing, and education for effective change. By December 2020, CDWC completed an intensive 6-month strategic planning and development phase to get ready for implementation of the program beginning January 2021.
