MEDICAL CARE SERVICES:THE ORGANIZATION OPERATES THE LARGEST COMMUNITY-BASED HEALTH CENTER IN PHILADELPHIA SERVING LGBTQ COMMUNITIES IN THE REGION. THE CENTER PROVIDES PRIMARY CARE, PREVENTATIVE CARE, GYNCOLOGICAL SERVICES, FAMILY PLANNING, HIV SCREENING AND CARE, STD SCREENING AND TREATMENT, LAB SERVICES, VACCINE ADMINISTRATION, DERMATOLOGY PROCEDURES, AND LGBTQ-SPECIFIC HEALTH SERVICES.CONTINUED ON SCHEDULE O.IN RESPONSE TO COVID-19, OUR HEALTH CARE, BEHAVIORAL HEALTH, PREVENTION, EDUCATION, LEGAL AND SOCIAL SERVICES MOVED TO VIRTUAL PLATFORMS TO PROVIDE TELE-CARE. ALL SERVICES WERE ABLE TO SUCCESSFULLY ADAPT TO PROVIDE QUALITY REMOTE OR HYBRID SERVICES TO OUR COMMUNITIES. AS A RESULT OF SHIFTING TO TELE-HEALTH SERVICES, THIRD PARTY BILLING DROPPED AS A RESULT OF LOWER REIMBURSEMENT FOR TELE-HEALTH SERVICES AND DECREASED IN-PERSON SERVICES RENDERED.

THE PROGRAM ALSO PROVIDES HOUSING SUBSIDIES AND FOOD BANK SERVICES FOR PEOPLE LIVING WITH HIV/AIDS AND THEIR FAMILIES. IN FISCAL YEAR 2020, OVER 2,700 INDIVIDUALS RECEIVED FOOD, CASE MANAGEMENT, GENDER AFFIRMING SERVICES, OR HOUSING SUBSIDY SERVICES.

IN FISCAL YEAR 2020, 848 INDIVIDUALS RECEIVED EDUCATION SERVICES.THE ORGANIZATION PROVIDES DIRECT LEGAL SERVICES TO LGBTQ INDIVIDUALS AND HOUSEHOLDS IN THE PHILADELPHIA REGION. IN FISCAL YEAR 2020, 665 INDIVIDUALS RECEIVED THESE SERVICES.

BEHAVIORAL HEALTH SERVICES:THE ORGANIZATION PROVIDES OUTPATIENT MENTAL HEALTH COUNSELING AND SUBSTANCE ABUSE TREATMENT, SPECIFICALLY SERVING LGBTQ COMMUNITIES IN PHILADELPHIA. SERVICES INCLUDE INDIVIDUAL, COUPLE, FAMILY, AND GROUP THERAPY. THE CONTINUUM OF BEHAVIORAL HEALTH SERVICES ALSO INCLUDES PSYCHIATRIC EVALUATION AND MEDICATION MANAGEMENT AS WELL AS AN INTENSIVE OUTPATIENT PROGRAM (IOP) FOR SUBSTANCE ABUSE. IN FISCAL YEAR 2020, THE ORGANIZATION CONDUCTED 10,487 BEHAVIORAL HEALTH SESSIONS FOR 622 UNDUPLICATED INDIVIDUALS. IN ADDITION, THE INTENSIVE OUTPATIENT PROGRAM HAS CONDUCTED 731 IOP SESSIONS WITH 50 INDIVIDUALS.
