THE INITIATIVES INCLUDE PROGRAMS TO PROVIDE TRAINING OF STUDENTS AND PROFESSIONALS ON THE CONNECTION BETWEEN BEHAVIORAL SCIENCES, HEALTH EDUCATION, HEALTH PROMOTION AND THE SURROUNDING ENVIRONMENT, AS WELL AS WORKING WITH OTHER NATIONAL ORGANIZATIONS, BUSINESSES, HOSPITALS, SCHOOLS, AND LOCAL COMMUNITIES TO REDUCE CHRONIC DISEASE RISKS DUE TO POOR NUTRITION, INACTIVITY, TOBACCO USE AND OTHER LIFESTYLE RISK FACTORS. THE MEETING PROVIDED A MAJOR SOURCE OF CONTINUING EDUCATION CREDITS FOR CERTIFIED HEALTH EDUCATION SPECIALISTS, MASTER CERTIFIED HEALTH EDUCATION SPECIALISTS, AND PERSONS CERTIFIED IN PUBLIC HEALTH. ADDITIONALLY, SOPHE SPONSORED A VIRTUAL DIGITAL HEALTH PROMOTION SUMMIT THAT ATTRACTED SOME 175 PARTICIPANTS ON THE IMPACT OF THE DIGITAL MEDIA ON HEALTH, INCLUDING COVID-19, GOVERNMENT, ACADEMIA, AND INDUSTRY.
