The Chinese Progressive Association educates and organizes the low income andworking class immigrant Chinese community in San Francisco to build collective powerwith other oppressed communities to demand better living and working conditions andjustice for all people.

Tenant Worker Center (TWC) - Workers Rights Outreach and Wage Clinic: This program provides outreach and education to low-wage immigrant workers about San Francisco labor laws including minimum wage and paid sick leave. The program also provides consultation on workplace violations and wage recovery, and referral to legal and other support services. Workers receive leadership development training and political education to develop their capacity to organize to win better living and working conditions. The TWC outreached to and educated over 10,000 workers about COVID-19 labor laws, health & safety protocols as they return to work, and unemployment insurance benefits.TWC Hospitality Vocational Training Program: This program provides ESL classes, vocational training, and job placement assistance to Chinese immigrant workers to enter careers in the hospitality sector with specific focus on hotels. The HVT program served 15 participants in 2020.

Youth Leadership/Development: Youth MOJO (Movement of Justice and Organizing) develops the leadership of working class Chinese American high school youth to engage in their communities through community education, leadership development, community-building, and hands-on organizing. This year, over 60 youth participated in the summer and school year programs. Youth began their journey with the annual Youth Leadership Retreat, where 40 attended to learn about CPA's history and campaigns, and to build community with each other. Youth apply their skills by leading campaigns and projects for healthy and equitable schools.

Political Empowerment Campaign (PEC) engages youth and adult leaders in civic programs - a structured voter education and mobilization program that promotes civic participation and builds a progressive voice for low-income and working class Chinese immigrants in local, statewide, and national politics. In 2020, PEC census program contacted over 17,500 Chinese immigrant residents. Additionally, the PEC voter education canvass program contacted over 20,000 Chinese voters in San Francisco, San Mateo, and Santa Clara counties, and mobilized 3,000 to vote in the 2020 general election.
