Strong and healthy churches are proven to affect positive changes in the lives of individuals and communities by sharing and applying the message of God's work through Jesus Christ.

Asia - Church planting and Scripture placement. This region is an area of growing ministry opportunity for MNM and during 2020 the organization continued to develop more ministry relationships and to build on it's base. We provide both scriptures and the type of training needed to those leaders with limited access to these resources. In 2020, over 169,300 Bibles were provided to those who have limited access.
