IN 2020, 1MISSION BUILT 44 HOUSES FOR FAMILIES IN EXTREME POVERTY IN MEXICO AND NICARAGUA. THESE HOMES PUT 196 PEOPLE IN SAFE AND DECENT SHELTER. THE FAMILIES COLLECTIVELY SERVED OVER 8,897 COMMUNITY SERVICE HOURS TO EARN THEIR HOMES, MAKING A SIGNIFICANT IMPACT IN THEIR COMMUNITIES. THE SAFETY, SECURITY, AND PEACE PROVIDED BY ADEQUATE SHELTER ARE FUNDAMENTAL FOR A HEALTHY LIFE. THESE HOMES SERVE AS AN ESSENTIAL FOUNDATION ON WHICH MORE COMPREHENSIVE, HUMAN, AND SUSTAINABLE COMMUNITY DEVELOPMENT PROGRAMS ARE BUILT UPON. THE HOUSE RECIPIENTS ARE PROVIDED WITH A 'STARTER HOME' THAT PROVIDES THE FAMILY WITH AN ASSET (EQUITY) THAT THEY DIDN'T PREVIOUSLY HAVE. DUE TO THE COVID-19 HEALTH EMERGENCY ECONOMIC DOWNTURN, 1MISSION RECEIVED APPROXIMATELY 38% FEWER DONATIONS DESIGNATED TO PROJECTS AND PROGRAMS COMPARED TO THE PRIOR FISCAL YEAR.

1MISSION HOUSES ARE BUILT BY LOCAL COMMUNITY MEMBERS WORKING TOGETHER WITH VOLUNTEERS FROM ALL OVER THE WORLD. THIS PARTNERSHIP IS CRITICAL FOR FOSTERING DIGNITY AND OWNERSHIP FOR THE HOME RECIPIENTS. IN 2020, OVER 1,164 PEOPLE FROM CHURCHES, BUSINESSES, SCHOOLS, AND OTHER GROUPS TRAVELED TO MEXICO TO HELP BUILD HOUSES ALONGSIDE LOCAL PEOPLE. THE PROVISION OF VOLUNTEER LABOR ADDS SIGNIFICANT VALUE BY PROVIDING THE RECIPIENT FAMILIES WITH AN ASSET WITHOUT INCURRING COSTS AND DEBT. THE VOLUNTEERS PROVIDE APPROXIMATELY 13,642 HOURS OF LABOR TO THE HOUSING PROJECTS SAVING ROUGHLY \$68,210 IN CONSTRUCTION COSTS. 1MISSION PROVIDES EXTENSIVE VOLUNTEER SUPPORT, HOUSING AND TRANSPORTATION, AS WELL AS A BASE-CAMP, TO THE VOLUNTEERS. DUE TO US AND MEXICAN LOCAL, STATE, AND FEDERAL HEALTH RESTRICTIONS DUE TO THE COVID-19 PANDEMIC, 1MISSION SUFFERED A LOSS OF 65% IN THE NUMBER OF TRIP PARTICIPANTS IN 2020 COMPARED TO THE PRIOR FISCAL YEAR, IMPACTING TRIP FEE REVENUE, THE NUMBER OF VOLUNTEER WORK HOURS, AND SAVINGS IN CONSTRUCTION COSTS.
