CLRJ EDUCATES POLICYMAKERS ON ISSUE AREAS THAT IMPACT THE 7.5 MILLION CALIFORNIA LATINAS, SERVES AS A THOUGHT LEADER AND COLLABORATOR WITH STATE AND NATIONAL ADVOCATES, TRAINS LEADERS ON THE POLICY PROCESS AND HOW TO ADVOCATE FOR THEMSELVES, AS WELL AS CONDUCTS STATE AND FEDERAL POLICY ADVOCACY TO IMPROVE THE HEALTH AND WELL-BEING OF LATINAS/XS AND THEIR FAMILIES IN CALIFORNIA. IN 2020, CLRJ CO-SPONSORED TWO BILLS AND ONE BUDGET REQUEST, AND ENGAGED IN STATE AND FEDERAL ADVOCACY TO URGE NECESSARY COVID-19 RELIEF, AND SUPPORTED ORGANIZATIONAL PARTNERS WITH A VARIETY OF OTHER LEGISLATIVE BILLS. CLRJ'S POLICY ADVOCACY TEAM SERVED ON VARIOUS COALITIONS AND ADVISORIES AND ENGAGED FORTY-SEVEN (47) POLICYMAKERS ONE HUNDRED AND ELEVEN (111) TIMES THROUGHOUT THE YEAR. MOST NOTABLY, CLRJ WAS SUCCESSFUL IN PASSING AB 732, THE REPRODUCTIVE DIGNITY FOR INCARCERATED PEOPLE ACT, WHICH WILL IMPROVE THE QUALITY OF REPRODUCTIVE HEALTH CARE, SUPPORT, AND ACCOMMODATIONS FOR INCARCERATED PEOPLE IN STATE PRISONS AND COUNTY JAILS BY CREATING A STATE MANDATED PROGRAM BY JANUARY 1, 2021. THIS WOULD ENSURE THAT THE RIGHTS OF INCARCERATED PEOPLE EXPERIENCING PREGNANCY, CHILDBIRTH, PARENTING, LACTATION, ABORTION, OR MENSTRUATION ARE PROTECTED WITH THE NECESSARY CARE, SUPPORT, SERVICES, AND ACCOMMODATIONS.

OUR UNION DE VECINAS DE BELL GARDENS - UNIDAS COMMUNITY LEADERS MET VIRTUALLY TWICE A MONTH TO PLAN FOR VIRTUAL AND LIMITED IN PERSON EVENTS TO INFORM THE BELL GARDENS COMMUNITY ABOUT TENANTS' RIGHTS CAMPAIGN FOR THE CITY OF BELL GARDENS THAT THEY ARE LEADING AND CLRJ IS SUPPORTING. CAMPAIGN ACTIVITIES INCLUDED: A COMMUNITY FORUM ON TENANTS RIGHTS, FLYERING AT SHOPPING CENTERS, A CAR CARAVAN WHERE OVER 15 CARS/40 PEOPLE PARTICIPATED, MEETING WITH STATE REPRESENTATIVES AND CITY OF BELL GARDENS COUNCIL MEMBERS, SPEAKING AT A VIRTUAL TOWN HALL MEETING DIRECTED AT GOVERNOR NEWSOM TO CANCEL RENT DURING THE PANDEMIC, DEVELOPING A STRATEGIC ORGANIZING CAMPAIGN PLAN AND PHONE BANKING TO LOCAL COMMUNITY MEMBERS. LASTLY, AS PART OF OUR VOTER ENGAGEMENT WORK WE REACHED OVER A THOUSAND COMMUNITY MEMBERS BY DISSEMINATING OUR 2020 VOTER GUIDE VIA OUR SOCIAL MEDIA PLATFORMS AND TEXTING OUR VOTER GUIDE LINK TO BELL GARDENS COMMUNITY MEMBERS IN OUR DATABASE.
