Due to Covid 19 in person Camps were cancelled and instead, we offered 2 Virtual Camps, one in March and one in October. The Virtual camps were five-day/four night sessions that took place primarily over Zoom, but utilized video clips from programmers and from our camp partners - Camp Twin Lakes in Rutledge, GA and YMCA Camp Harrison in Boomer, NC. The website is maintained for camper sign-up and for recruitment of volunteers. There is extensive planning for camp sessions for adults with developmental disabilities. The Spring Virtual camp (Camp in a Box) served 121 adults with help from 138 volunteers while the Fall Virtual camp served 94 adults with help from 46 volunteers.
