THE HOME CONTAINS BOTH PRIVATE AND SHARED SPACE SO RESIDENTS CAN DEVELOP SELF-DISCIPLINE AND INTERPERSONAL SKILLS. ADDITIONALLY, DURING THE LAST FISCAL PERIOD 74 APPLICANTS APPLIED TO THE PROGRAM AND 3 OF THE YOUNG WOMEN GRADUATED FROM THE SAVING GRACE PROGRAM.
