Form 990, Part VI, Section A, Line 6	SEFAA had 9 organizational members and 151 individual members at the end of 2020. Memberships are good for a full calendar year from the date of payment and are rolling, rather than calendar-year, memberships. Annual membership dues are \$60 for individuals (discounted to \$15 for students and \$55 for members of SEFAA member organizations) and \$100 to \$300 for organizations and businesses depending on their size. Members elect SEFAA's Board of Directors, but do not approve Board decisions or share in any of the Corporation's earnings.

Article 11.5.4.3 of the SEFAA Bylaws states: The board or compensation committee shall obtain and rely upon appropriate data as to comparability prior to approving the terms of compensation. Appropriate data is described in 11.5.4.3.1 through 11.5.4.3.5. Article 11.5.4.4 of the SEFAA Bylaws states: The terms of compensation and the basis for approving the same shall be recorded in written minutes of the meeting of the board or compensation committee that approved the compensation. The details of the required documentation are specified in 11.5.4.4.1 through 11.5.4.4.7. At this time, SEFAA is a completely volunteer-run organization, so the process described above is not in current use.</p>

Form 990, Part XI, Line 9	Assets are increased by library donations which total \$2,580. Assets are decreased by \$26.94 (to correct minor errors in 2018 and 2019 accounts) and a \$1 rounding error. Total change in assets = $\$2,580 - \$26.94 - \$1 = \$2,552.06$ .
