UFM MADRID CAMPUS: IN 2018, UFM BEGAN OPERATIONS IN MADRID, SPAIN, WHERE IT OPERATES AS A FOREIGN UNIVERSITY. THE ORGANIZATION HAS A PROGRAM TO SUPPORT THIS CAMPUS. AS CLASSES BEGAN IN SEPTEMBER 2018, UFM BECAME THE ONLY LATIN AMERICAN UNIVERSITY AUTHORIZED TO OPERATE IN EUROPE. IT IS LOCATED IN ONE OF THE MOST POPULAR COUNTRIES FOR STUDY ABROAD AND ONE OF THE WORLD'S MOST COMPETITIVE ACADEMIC MARKETS FOR BUSINESS ADMINISTRATION AND ENTREPRENEURSHIP. AS A FOREIGN UNIVERSITY OPERATING IN SPAIN, THE OPPORTUNITIES TO DEVELOP NEW EDUCATIONAL PRODUCTS THAT ADDRESS THE IMPORTANCE OF LIBERTY IN ALL ITS MANIFESTATIONS ARE IMMENSE. AYAU SOCIETY, WHICH WAS ESTABLISHED BY UFM TO HONOR THE LEGACY OF MANUEL F. AYAU AND SUPPORTS SCHOLARS AND PROFESSORSHIPS; SUMMER PROGRAMS AT UFM'S MADRID CAMPUS AND OTHER LOCATIONS; AND OTHER DONOR-RESTRICTED SCHOLARSHIPS.

TODAY THEY ARE THE MOST VALUABLE LEARNING TOOL THAT LEVERAGES WHAT WE KNOW ABOUT THE HUMAN BRAIN AND HOW IT LEARNS. VIDEO GAMES HAVE BECOME A GIANT GLOBAL MARKET. THEY ARE THE MOST POWERFUL INFLUENCE ON CULTURE AND ONE OF THE BIGGEST INFLUENCERS IN THE EDUCATION OF OUR CHILDREN. THEY ARE WHERE CHILDREN INVEST THE GREATEST SHARE OF THEIR FREE TIME--MORE THAN MOVIE, VIDEOS, MUSIC, AND TELEVISION COMBINED. IN FEBRUARY 2018, UFM LAUNCHED A BOOTSTRAP VIDEO GAME CENTER PULLING FROM INSTALLED CAPACITIES AND TEMPORARILY SHARING RESOURCES WITH VARIOUS UFM DEPARTMENTS. UFM IS IN A UNIQUE POSITION TO OPERATE A VIDEO GAME CENTER FOR A FRACTION OF THE USUAL COST BECAUSE UFM ALREADY HAS MUCH OF THE KNOWLEDGE, INFRASTRUCTURE, AND PEOPLE IN PLACE--SOFTWARE AND COMPUTER LABS, AND AN ENDLESS PIPELINE OF TALENTED STUDENTS ITCHING TO DIVE IN. UFM IS WORKING TO INTEGRATE THE VIDEO GAME CENTER INTO UNDERGRADUATE CURRICULUM AND CREATE PROJECTS THAT DRAW FROM ACROSS DISCIPLINES.

OTHER PROGRAMS AND ONE-TIME PROJECTS: THE ORGANIZATION PROVIDES SUPPORT TO ADMINISTER THE OTHER PROGRAMS AND ONE-TIME OR SPECIAL PROJECT SUPPORT TO UNIVERSIDAD FRANCISCO MARROQUIN (UFM). IN 2020, THE ORGANIZATION PROVIDED A \$49,950 GRANT TO UFM FOR THE COLLEGE FREEDON FORUM, A ONE-DAY EVENT TO CONNECT STUDENTS WITH HUMAN RIGHTS ACTIVISTS, A \$50,000 GRANT FOR ALTERNATIVE DELIVERY METHODS OF EDUCATION, AND A \$638 GRANT FOR THE CENTRO DE ESTUDIO DEL CAPITALISMO. THE ORGANIZATION ALSO HAS MADE GENERAL SUPPORT GRANTS OF \$137,393 IN THE YEAR ENDED DECEMBER 31, 2020, TO UFM TO BE ADMINISTERED BY THE UFM PRESIDENT'S OFFICE AT THE DISCRETION OF THE UFM PRESIDENT. IN ADDITION, THE ORGANIZATION HAS PLEDGED A DONATION OF 124 VOLUMES TO THE UFM LIBRARY.
