TRAINING MOBILIZATION - TTV'S ONLINE TRAINING PLATFORM FEATURED A VARIETY OF AVAILABLE COURSES INCLUDING ELECTION WORKER TRAINING, ELECTION INTEGRITY OVERVIEWS, SIGNATURE COMPARISON TRAINING, AND FOCUSED TRAINING FOR STATE SPECIFIC POLL WATCHERS, MAIL-IN REVIEW, CENTRAL COUNT, AND ELECTION LITIGATION PROGRAMS, ALL TAILORED TO ADDRESS THE OVERWHELMING CHANGES THAT 2020 BROUGHT TO THE ELECTION PROCESS. THOUGH COVID MADE TRAINING DIFFICULT, TTV'S ONLINE PROGRAMS WERE VIEWED BY OVER 25,000 TRAINEES. NATIONAL ELECTION INTEGRITY HOTLINE - TTV HOSTED A NATIONAL PLATFORM FOR REPORTS OF ELECTION RELATED INCIDENTS. VOTERS FILED REPORTS ONLINE, VIA SOCIAL MEDIA , OR USED A TOLL-FREE CALL-IN NUMBER WHERE LIVE OPERATORS ANSWERED CALLS. BETWEEN SEPTEMBER 15TH AND DECEMBER 31ST OVER 10,000 REPORTS WERE LOGGED THROUGH THE HOTLINE.
