THIS PAST YEAR WE SERVED INDIVIDUALS FROM 24 COUNTIES (OUT OF A TOTAL OF 33) IN NEW MEXICO AND PROVIDED DIRECT REPRESENTATION, ADVICE, AND BRIEF SERVICES TO 2,835 INDIVIDUALS. IN ADDITION, WE PROVIDED PRO SE SUPPORT TO INDIVIDUALS APPLYING FOR CITIZENSHIP, GREEN CARD RENEWAL, AND WORK PERMIT RENEWAL THROUGH FREE LEGAL CLINICS AND WORKSHOPS.
