March 2020 - the ACHPR adopts another resolution to develop norms on States obligations to regulate private actors involved in the provision of social services.July 2020 - Echoing key concepts from the Abidjan Principles on the right to education, the ACHPR publishes its Guidelines on the Right to Water in Africa, requiring substantive and procedural conditions to be met before the State may delegate the provision of water services to a private actor.October 2020 - Over 500 participants attend the first online panel event bringing together eight United Nations (UN) special procedures mandate holders to discuss the impacts of privatisation on public services and alternatives. GI-ESCR manages to spark the interest of 14 major media outlets worldwide, in the open editorial signed by five of the current and former UN mandate holders joining the panel. The Abidjan Principles influence the policies of major education donors such as the Global Partnership for Education, the largest global fund dedicated to education and the International Finance Corporation, the corporate arm of the World Bank. Both of which decide to move away from for-profit education investments, in June 2019 and April 2020.
