MODEL ENVIRONMENTS: DURING THE IMPACT 2020 BUSINESS PHASE, IFYC SIGNIFICANTLY DEEPENED INTERFAITH LEADERSHIP PRACTICES ON 544 COLLEGE AND UNIVERSITY CAMPUSES ACROSS THE COUNTRY; MORE THAN 200 OF THESE SCHOOLS WERE NOT IN RELATIONSHIP WITH IFYC BEFORE THIS 5-YEAR PERIOD. THESE NUMBERS WOULD HAVE BEEN EVEN HIGHER, BUT THE UPHEAVAL ACROSS HIGHER EDUCATION CAUSED BY THE COVID-19 PANDEMIC LIMITED BOTH OUR NORMAL OUTREACH TO EMERGING CAMPUSES AND OUR DATA GATHERING EFFORTS. IFYC DEEPENED WORK WITH CAMPUS PARTNERS AND BROADENED IMPACT ACROSS THE HIGHER EDUCATION SECTOR. THROUGH CAMPUS VISITS, SPEAKING ENGAGEMENTS, AND CAMPUS-WIDE SUPPORT, INCLUDING INNOVATION AND CURRICULUM DEVELOPMENT GRANTS, IFYC BUILT STRONG AND EFFECTIVE RELATIONSHIPS WITH HUNDREDS OF SENIOR ADMINISTRATORS, FACULTY, AND STAFF. WE ARTICULATED A HIGH STANDARD OF EXCELLENCE FOR LAUNCHING AND SUSTAINING INTERFAITH INITIATIVES, KNOWING THAT THESE MODEL ENVIRONMENTS WOULD SERVE AS EXEMPLARS FOR OTHER SCHOOLS. TO EXPAND OUR REACH, IFYC ALSO ESTABLISHED AND MAINTAINED AN ACTIVE PRESENCE ACROSS NUMEROUS HIGHER EDUCATION NETWORKS.
