In FY20, MediaJustice successfully pressured Facebook to publicly release the results of an independent civil rights audit, launched a public education campaign to disrupt racialized disinformation, pressured Twitter to ban white supremacists from their platform, pressured tech companies to issue moratoriums on the sale of facial recognition technology and launched a campaign targeting Amazons sale of surveillance technology. The organization expanded to a dues paying membership of 110 and our digital campaigns engaged over 20,000 individuals.
