

IN 2020, CRMF SUPPORTED LITERACY OUTREACH IN THIRTEEN LOCATIONS INCLUDING TWO AT TOAMASINA CITY PRISON. SINCE ITS INCEPTION, SOME SIXTEEN YEARS AGO, CRMF HAS CELEBRATED THE GRADUATION OF 20,000 ADULTS FROM ITS FUNCTIONAL LITERACY PROGRAM WHICH IS IMPLEMENTED BY OUR ONG ST. GABRIEL PARTNERS. THIS PROGRAM INCLUDES THE BASIC SKILLS OF READING, WRITING AND MATH, AND INCORPORATES INTO THE CURRICULUM TOPICS SUCH AS GOOD HYGIENE, SANITATION, NUTRITION, HOW TO PLANT AND NURTURE A FAMILY GARDEN, AND HOW TO CREATE A FAMILY BUDGET. THESE CLASSES ARE TAUGHT IN MALAGASY, THE LANGUAGE OF THE POOR, NOT IN FRENCH, THE LANGUAGE OF THE LEARNED AND THE PUBLIC SCHOOLS. THE LITERACY INITIATIVE IS THE FEEDER PROGRAM FOR THE WOMEN'S SELF-HELP GROUPS. THEIR COMBINED GOAL IS TO PROVIDE A PATH TO ECONOMIC SELF-SUFFICIENCY FOR POOR WOMEN. OUR LITERACY INITIATIVE ALSO CONTINUES TO SUPPORT TECHNOLOGY EDUCATION FOR POOR YOUTH, GIVING THEM ACCESS TO COMPUTER TRAINING. IN ADDITION, THE LITERACY INITIATIVE PROVIDES EMPLOYMENT FOR THE LOCAL MALAGASY PEOPLE WHO SERVE AS TEACHERS. SINCE ITS INCEPTION, SOME SIXTEEN YEARS AGO, CRMF HAS CELEBRATED THE GRADUATION OF 20,000 ADULTS FROM ITS FUNCTIONAL LITERACY PROGRAM WHICH IS IMPLEMENTED BY OUR ONG ST. GABRIEL PARTNERS. THIS PROGRAM INCLUDES THE BASIC SKILLS OF READING, WRITING AND MATH, AND INCORPORATES INTO THE CURRICULUM TOPICS SUCH AS GOOD HYGIENE, SANITATION, NUTRITION, HOW TO PLANT AND NURTURE A FAMILY GARDEN, AND HOW TO CREATE A FAMILY BUDGET. THESE CLASSES ARE TAUGHT IN MALAGASY, THE LANGUAGE OF THE POOR, NOT IN FRENCH, THE LANGUAGE OF THE LEARNED AND THE PUBLIC SCHOOLS. THE LITERACY INITIATIVE IS THE FEEDER PROGRAM FOR THE WOMEN'S SELF-HELP GROUPS. THEIR COMBINED GOAL IS TO PROVIDE A PATH TO ECONOMIC SELF-SUFFICIENCY FOR POOR WOMEN. OUR LITERACY INITIATIVE ALSO CONTINUES TO SUPPORT TECHNOLOGY EDUCATION FOR POOR YOUTH, GIVING THEM ACCESS TO COMPUTER TRAINING. IN ADDITION, THE LITERACY INITIATIVE PROVIDES EMPLOYMENT FOR THE LOCAL MALAGASY PEOPLE WHO SERVE AS TEACHERS.

SOME FOUR THOUSAND PEOPLE, MORE THAN 800 FAMILIES, CALL ANALAMALOTRA THEIR HOME, MAKING IT THE LARGEST OF OUR MHV ENDEAVORS. CRMF WAS ABLE TO RAISE 100,000 IN SUPPORT OF THIS EFFORT. THE MODEL HEALTHY VILLAGE INITIATIVE WON A SECOND ROTARY FOUNDATION GLOBAL GRANT IN 2020. DATA COLLECTED DURING OUR PAST MHV PROJECTS HAVE SHOWN THAT THE INTRODUCTION OF THE BASIC HYGIENE MEASURES MENTIONED ABOVE HAS SUBSTANTIALLY REDUCED BOTH SCHOOL ABSENTEEISM AND THE RATE OF INFECTIOUS DIARRHEA AMONG THE OVERALL POPULATION. IN ADDITION, THE USE OF THE ENVIRONMENTALLY FRIENDLY SMOKELESS OVEN HAS REDUCED THE OCCURENCE OF RESPIRATORY DISEASE.

THEY HAVE DEVELOPED THEIR OWN CONSTITUTIONS, ELECTED GROUP LEADERS, AND SET SAVINGS GOALS. WITH HELP FROM A GRANT AWARDED BY A LOCAL FOUNDATION, CRMF HAS FUNDED A LOAN POOL FROM WHICH THE WOMEN CAN BORROW IN ORDER TO ADVANCE THEIR SMALL BUSINESS PROJECTS.

CRMF ALSO FUNDED A HYGIENE INSTRUCTION AND SUPPLIES PROJECT FOR PARTICIPANTS IN MORE THAN A DOZEN LITERACY CENTERS AND AT THE LOCAL PRISON. CRMF FUNDED THE PURCHASE OF PERSONAL PROTECTIVE GEAR FOR THE ONG ST. GABRIEL TEAM, FOR THE MIDWIVES AT THE ANKIRIHIRY CSB II LOCAL CLINIC AND AT THE CLINIC FOR THE POOR OPERATED BY THE DOCTORS OF THE ASSOCIATION SNATE POUR TOUS (AST).
