WE CREATE AND MANAGE TINY HOME VILLAGES THAT FOSTER COMMUNITY, ENCOURAGE PERSONAL GROWTH, AND PROMOTE ACCESS TO THE CARE AND SERVICES RESIDENTS NEED. IN 2019 WE STARTED A PARTNERSHIP WITH LOCAL MENTAL HEALTH PROFESSIONALS TO PROVIDE ONE-ON-ONE THERAPY TO RESIDENTS ON SITE.
