CALIFORNIA HEALTH - THE CONVERGENCE CALIFORNIA HEALTH REFORM INITIATIVE BROUGHT TOGETHER HIGH-PROFILE STAKEHOLDERS REPRESENTING CONSUMERS, HEALTH CARE PROVIDERS, INSURERS, WORKERS, EMPLOYERS, AND ACADEMICS TO PARTICIPATE IN CONFIDENTIAL, FACILITATED DIALOGUES DESIGNED TO FIND SOLUTIONS TO RISING HEALTH CARE COSTS. DURING THE 18 MONTHS OF SESSIONS, THE GROUP EXCHANGED IDEAS, ANALYZED SEVERAL COST-CONTAINMENT OPTIONS, AND DEVELOPED CONSENSUS AROUND RECOMMENDATIONS FOR THE STATE TO CREATE A GOVERNMENT ENTITY TO SET COST TARGETS FOR HEALTH CARE PROVIDERS AND INSURERS BASED ON COST DATA SUBMITTED BY PROVIDERS. IN 2020, LEGISLATION MIRRORING THE RECOMMENDATIONS WAS PROPOSED BY THE GOVERNOR AND STATE LEGISLATURE TO ESTABLISH THE OFFICE OF HEALTH CARE AFFORDABILITY.

GUNS AND SUICIDE PREVENTION - DIVISIVENESS AROUND GUN POLICY HAS GROWN WIDER OVER THE LAST FEW YEARS, AND THE RATE OF GUN-RELATED DEATHS BY SUICIDE HAS INCREASED, NOW ACCOUNTING FOR HALF OF THE NATION'S SUICIDES. THE PANDEMIC, UNEMPLOYMENT CRISIS, AND RESULTING SURGES IN MENTAL HEALTH CHALLENGES COMPOUND THE CRISIS, BUT DIVISION LINGERS. IN 2020, CONVERGENCE CONVENED A DIVERSE GROUP OF LEADERS WITH WIDELY DIVERGENT VIEWS ON GUN RIGHTS TO FIND SOLUTIONS. PARTICIPANTS INCLUDE RESEARCHERS, MEDICAL DOCTORS/MENTAL HEALTH EXPERTS, GUN RIGHTS ADVOCATES, GUN INDUSTRY LEADERS, GUN VIOLENCE PREVENTION ADVOCATES, FAITH LEADERS, AND COMMUNITY ORGANIZERS FOCUSED ON UNDERSTANDING GUN OWNERSHIP, IDENTIFYING STRATEGIES TO PREVENT FIREARM SUICIDE, AND DRIVING ACTIONABLE CHANGE. THEIR WORK WILL CONCLUDE IN LATE 2021.

CONGRESS - AMERICA'S DISRUPTIVE DISCOURSE AND POLITICAL POLARIZATION HAVE REACHED DANGEROUS LEVELS. SUCH TOXICITY PRESENTS A THREAT TO DEMOCRACY AND REPRESENTS THE SINGULAR MOST CRITICAL ISSUE FACING THE NATION. TO FIGHT AGAINST TOXIC POLARIZATION, CONVERGENCE WORKS WITH THE BIPARTISAN WORKING GROUP OF CONGRESS TO STRENGTHEN RELATIONSHIPS ACROSS THE AISLE AND FIND COMMON GROUND AMONG MEMBERS. CONVERGENCE FACILITATES MEETINGS WITH A DIVERSE NETWORK OF EXPERTS TO EXPLORE COMPLEX POLICY ISSUES, EXCHANGE VIEWPOINTS, AND DEEPEN THEIR UNDERSTANDING OF MEMBERS' PERSPECTIVES. CONVERGENCE ALSO SUPPORTS THE HOUSE SELECT COMMITTEE ON THE MODERNIZATION OF CONGRESS, A BIPARTISAN COMMITTEE TASKED WITH CRAFTING RECOMMENDATIONS TO HELP CONGRESS WORK MORE EFFICIENTLY.
