IN 2020 FAC ACHIEVED THESE IMPORTANT VICTORIES FOR OPEN GOVERNMENT AND THE PUBLIC'S RIGHT TO KNOW: FAC USES LITIGATION TO ESTABLISH NEW LEGAL RIGHTS AND TO ENFORCE EXISTING REQUIREMENTS ON RELUCTANT GOVERNMENT AGENCIES. SOME HIGHLIGHTS:--FAC PREVAILED IN THE CALIFORNIA COURT OF APPEAL AGAINST THE CALIFORNIA ATTORNEY GENERAL IN A LAWSUIT BROUGHT TO ENFORCE SB 1421, A LANDMARK BILL THAT BRINGS NEW TRANSPARENCY TO RECORDS OF POLICE MISCONDUCT. THIS APPELLATE VICTORY ESTABLISHED GOOD NEW LAW IN CALIFORNIA, ADVANCING THE RIGHT OF THE PRESS AND PUBLIC TO RECORDS CRUCIAL TO ENSURING POLICE ACCOUNTABILITY. 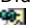
