THE FOUNDATION FOR THE CHILDREN IS PART OF AN INTERNATIONAL VENTURE DEDICATED TO SUPPORT HOSPITAL INFANTIL AND ITS MISSION OF IMPROVING THE HEALTH OF CHILDREN FROM ACROSS THE REGION OF SOUTHERN CALIFORNIA AND NORTHERN BAJA CALIFORNIA, BY PROVIDING AFFORDABLE MEDICAL, NUTRITIONAL, AND DENTAL CARE AS WELL AS HEALTH AND NUTRITION EDUCATION. WITH THE SUPPORT OF THE FOUNDATION FOR THE CHILDREN, THE FOUNDATIONS IN MEXICO AND CANADA, AND THE GENEROUS SUPPORT OF THE PUBLIC ACROSS THE REGION, CORPORATE SPONSORS AND PHILANTHROPISTS, HOSPITAL INFANTIL IS A MODEL PEDIATRIC SPECIALTY FACILITY THAT PROVIDES SERVICES TO CHILDREN FROM ACROSS THE REGION, REGARDLESS FOR THEIR ABILITY TO PAY FOR THE SERVICES.
