THROUGH THE NONPROFIT VETERINARY CLINIC, MCHA PROVIDED DIRECT VETERINARY SERVICES TO MORE THAN 6,958 PATIENTS SEEKING CARE FOR WELLNESS, INJURY AND SURGERY SERVICES. THROUGH MOBILE CLINICS, MCHA PROVIDED WELLNESS SERVICES OFF-SITE IN UNDERSERVED COMMUNITIES TO 504 PATIENTS. IN 2020, MCHA ISSUED 1,024 SPAY-NEUTER ASSISTANCE VOUCHERS TO OFFSET THE DIRECT COSTS OF SPAY NEUTER PROCEDURE WITH A LOCAL VETERINARY PARTNER.
