HANA's Education & Workforce Empowerment programs engage more than 750 immigrant community members to develop their critical capacity and cultural rootedness, and advance economic justice. Programs included job readiness/technology classes, one-on-one coaching and workers' rights training, citizenship classes and one-on-one tutoring, and Korean language and art classes.

IMMIGRATION, LEGAL, & HOUSING SERVICES

HANA Center's Citizenship, Immigration, Legal & Housing Services engages more than 5,500 immigrant community members to apply for citizenship, DACA and other immigration status adjustments, receive free legal clinic sessions, and engage housing counseling services.
