PEACE AND DIPLOMACY WITH NORTH KOREA: PEACE ACTION'S PRESIDENT CHAIRS THE KOREA PEACE NETWORK, A NATIONAL GRASSROOTS NETWORK OF KOREAN-AMERICAN, FAITH, PEACE, HUMAN RIGHTS AND LABOR GROUPS PROMOTING DIPLOMACY BETWEEN THE US AND NORTH KOREA.
