The Southwest Organizing Project's (SWOP) mission is to build a broad-based organization of Christian, Muslim and Jewish faith institutions, local schools and other institutions in Southwest Chicago, which will enable families to exercise common values, determine their own future and connect with each other to improve life in their neighborhoods. To this end, leaders of SWOP have dedicated themselves to building relationships across racial, ethnic, generational and faith differences and to bringing the common concerns of their institutions into the public life of the community as they develop the capacity to act collectively and "stand for the whole."

Housing Issues:

Chicago Southwest is fortunate to have a solid, affordable housing stock, made up mostly of single family bungalows. For years, Chicago Southwest was targeted by sub-prime lenders who preyed on many first time homebuyers in the community. Even before the financial crisis of 2007-08, Chicago Southwest was suffering a foreclosure crisis. Working with Neighborhood Housing Services, Greater Southwest Development Corporation, and others, SWOP helped over 625 families keep their homes through our anti-foreclosure work. Unfortunately, many others could not be saved due to the high volume of foreclosures.

In 2013 there were nearly 700 vacant properties in the Reclaiming Southwest Chicago Target Area. SWOP and partner Brinshore Development are purchasing and rehabbing buildings which will then be rented or resold.

The SWOP/Brinshore Reclaiming Southwest Chicago effort seeks to acquire, rehab and

reoccupy 100 vacant units within a 3-square mile target area. We have focused our efforts in and around the Chicago Lawn Micro Market Recovery Program (MMRP) area. Over the past three years our work has been responsible for reducing vacant properties in the MMRP from 80 units to 25. To date, SWOP has raised over \$11 million for the Reclaiming Southwest Chicago initiative.

In SWOP's work to create safer communities, outreach workers build relationships with community members. Through these relationships, they work to interrupt violence and encourage other ways of solving conflicts. This work is reducing the number of shootings in the neighborhood. Outreach workers also connect people with resources including jobs, education, legal aid, and behavioral health.

To do this work, SWOP partners with Communities Partnering 4 Peace. Workers are also being trained in the Peace Academy where expert peacemakers are sharing their wisdom and tools with one another. The program is built from relational and experiential knowledge.

Healthcare-related organizing:

SWOP partners with Holy Cross Hospital and Esperanza Health Center to ensure community access to high-quality health care. In addition, SWOP recently completed a community-wide health plan detailing work to be done to improve the health outcomes of neighborhood residents. Activities include working to improve access and affordability of healthcare for the undocumented; working to increase and educate residents on how to navigate the health system so they can make the best choices for their families; working to promote the long-term viability of health

institutions in the community; and working to promote access to health insurance.

In the past, SWOP has assisted families in signing up for ACA and AllKids insurance.

SWOP organized a Southwest System of Care Network (SWSOC). SWOP used a community organizing model of relationship building to bring together mental health, healthcare, and social service providers with schools, after-school providers, youth leadership development programs, and others to meet the holistic needs and build on the assets of the communities' young people and their families.

Citizenship and Immigration:

SWOP has been working for a path to citizenship for all immigrants since its foundation in 1996. SWOP has been active and visible throughout the years, participating in marches and demonstrations against anti-immigrant laws that pose a danger to our community. SWOP has been a key actor in a range of successful local, statewide, and national campaigns on behalf of immigrant families.

Some of the campaigns our leaders and staff have been working on include:
